"New Flight Plan Format in the NextGen Environment" by Christophe Masiero – The FAA recently postponed the transition to the ICAO flight plan format to the end of the year.

Christophe will explain reasons for the postponement and discuss differences from the current domestic format. He will discuss preparing and filing with the new format using examples in ForeFlight and Garmin Pilot applications.
