"New Flight Plan Format in the NextGen Environment" by Christophe Masiero -

With the equipment mandate of 2020 under way, the FAA has recently postponed the transition to the ICAO flight plan format to the end of the year. Christophe Masiero will explain the rational (why) about this move in the NextGen/ADS-B context and provide an overview of the differences with the current domestic format (what). He will share about preparation and filing (how) with the new format using standard cases and examples in ForeFlight and Garmin Pilot applications.
