# **Touch Down At JAARS Helicopter Fly in and FAASTeam Safety Seminar**

Event opens at 0830, with classes at 1030 and 1330

Join us as we delve into one particular helicopter accident, discuss the tragedy of three lost lives, and help you see that many operational decisions are not black and white choices.

Aviation Safety Inspectors from the Charlotte Flight Standards Office will lead an in-depth session about a safety-conscious helicopter pilot who died while trying to fly a very noble mission. The webinar will use the NTSB accident report, photos, animation, and pilot background data to weigh the consequences of each operational decision. We will analyze the decision-making processes that can lead to disaster and determine what we can do to avoid falling into similar traps.

**Directions:** Training will be conducted in the classroom, lower floor of the Aviation Administration Building From I-77, Rock Hill, SC-Follow E Main St, US-21 S/Anderson Rd S and SC-5 E to SC-75 E in Lancaster County. Take the SC-5 S exit toward Roddey/Lancaster. Turn left onto SC-75 E. Turn left onto US-521 N. Take Rehobeth Rd and Walkup Rd to Jaars Rd in JAARS. Destination will be on the left.

From Charlotte/485 Outer- Take exit 61 for US-521/Johnston Rd. Use the right 3 lanes to turn right onto US-521 S/Johnston Rd. Turn left onto Niven Rd. Left onto Rehobeth Rd. Turn right onto Walkup Rd. Slight left to stay on Walkup Rd. Turn left onto Jaars Rd. Destination will be on the left
