**Auto traffic:** Upon arriving onto Main Entrance of KARR airport property, At 1<sup>st</sup> opportunity Look and turn left West – 1<sup>st</sup> Building. Drive onto the parking lot furthest West. Classroom on your right (Passenger's side).

**Aircraft traffic:** Request taxi to West Ramp – JA Air Center. Continue Taxi past the large overhang at JA Aviation Air Center. Continue taxi past and park furthest onto South Ramp between JA Maintenance Building and Building to your South side. NOTE: On Google Maps it is shown as Northrop Aviation Dispatch Academy.
