## **Shooting An Approach to Your Aviation Medical Certificate**

Successful completion of either an FAA medical certificate or BasicMed certificate requires much the same preparation as we do before we initiate a flight! The pilot needs to decide what type of medical certificate is required to meet her/his needs, preflight the exam by organizing the medical history and providing any information necessary for Special Issuance (if needed) and, if in doubt, asking questions from the AME or physician before the exam.

A 9000 hour commercial rated pilot, he holds instrument, multiengine and seaplane ratings.
