Directions: From I-4, take Exit 25 (County Line Rd.) south to a left turn (east) at Medulla Rd. Take Medulla Rd. to the main entrance at Sun-n-Fun. Your landmark is the Thunderbirds T-33 jet on a pedestal. Slow down, go straight ahead; do not take the sweeping curve to the right! The road now becomes James C. Ray Rd. (ex-Doolittle Rd.). Proceed under 10 mph and with caution through the gate and go another 0.2 mi, approaching the airport security fence straight ahead of you. Turn left (north) at Sun 'n Fun Rd. and proceed another 0.2 mi. The Orlando Field Office (aka FAA Safety Center) is the last permanent structure on the left. Normally, park along west side of the OFO. If Sun-n-Fun is hosting another large event, alternate parking procedures may be in effect. These will be announced at the event.
