Monroe Regional Airport Runway Safety Action Team (RSAT) Meeting

You are cordially invited to attend the Runway Safety Action Team (RSAT) meeting on Tuesday, June 25, 2019 at 9:00 a.m. in Conference Room #3 on the 1st floor of the Monroe Regional Airport terminal (across from the American Airlines ticket counter).

The purpose of this meeting is to unite those individuals and organizations that are actively involved in air traffic operations and the movement of aircraft, vehicles, and equipment on the Airport Operations Area (AOA). Runway incursions remain a serious concern nationally, and one important component of our ongoing efforts to improve surface safety at Monroe Regional Airport involves conducting this meeting at least once each year.

We look for participation from all major airport interests, including tenants, fixed based operators, airport operations, and maintenance personnel. Participants are asked to help develop recommendations and solutions to enhance surface safety. Those recommendations serve as the foundation for a site-specific Runway Safety Action Plan (RSAP).

Directions: From the Shreveport and Ruston areas, Head east on I-20 E and take exit 120 for Garrett Rd toward "Monroe Airport". Make a sharp left onto Garrett Rd. Turn left onto LA-594. Turn right at the 1st cross street onto Kansas Ln. Turn right at the 1st cross street onto Construction Ave. Construction Ave turns slightly right and becomes Operations Rd.

Short Term Parking will be on your left across from the large red hangar and just before you reach the Main Terminal. Be sure to take your parking ticket/receipt into the safety meeting for validation prior to leaving.

After parking, walk across the street towards the terminal and enter through the main entrance for "Ticketing/Check-In" under the large canopy. Conference Room #3 on the 1st floor of the Monroe Regional Airport terminal (across from the American Airlines ticket counter).
