From the west valley, take I-10 to the exit for Sky Harbor International Airport (exit 149). From the Southeast valley, take I-10 to the Hohokam Expressway, AZ-143 (Exit 153A) to E. Sky Harbor Blvd (Exit 3B). From the East and Northeast valley take AZ-202 to E. Sky Harbor Blvd (Exit 5). From the Terminal 3 parking garage and walk towards Terminal 4. Guard shack is located on the south side of the terminals between terminal 3 and terminal 4. Parking will not be validated, participants are responsible for finding their own parking.

Visitors must be US citizens with valid **REAL ID photo ID (See Attached Flyer about REAL ID)**. All visitors will go through security screening.
