


## FAASafety.gov Enhancements and Updates

As of October 22, 2008

1. An updated graphic describing the **WINGS** - Pilot Proficiency Program is in the **WINGS** - Pilot Proficiency Program help file.



The new grid uses the revised coding, such as "C" for Core instead of "R" for Required, to better describe the Phase requirements.



2. Events and Activities will now be sorted in all lists to show the "no fee" items first and those with a cost, last.
3. The activity search function has been improved, so that activities can be found more easily. In addition, the search boxes now stay open between searches.
4. A help file was added to describe the process for Transferring a Representative from one Region to another, or from one District to another in the same Region. It is found, as many help files are, by clicking on the green circle with a question mark  on the "View the Active Directory" page.
5. The word "Adjusted" is now used in place of "Revoked" when changes are made to credits in the **WINGS** - Pilot Proficiency Program.

6. An instruction was added to the SPANS Events Additional Information Free Text Box that says any links placed in the box must be preceded with http:// (and gives an example - <http://www.faa.gov/>).
7. When a user requests validation of a credit, an email goes to the validator. When that request is validated (or "rejected"), an email now goes to the requestor, as well as the validator, saying the request was either validated or not validated.
8. A new link takes users to a page with instructions about how to include the FAASafety logo and URL in other publications and/or web sites. It is found under "[About the FAASafety Team.](#)"



9. FAASafety.gov is proud to announce that we now host the FAA-Approved IA Refresher Course list. It can be found under the Maintenance Hangar link.



10. As a reminder, remember that when an airman who is not registered on [FAASafety.gov](http://FAASafety.gov) attends an event and is given credit for that event by the event closer, their email address is maintained in the database. That user is automatically given that credit when they register on [FAASafety.gov](http://FAASafety.gov) with the same email address. Event closers can see the new language that alerts the closer that the attendee (or at least the email address entered) was not registered at the time the event was closed.
